Description

To restore and maintain active certification status, recertification is required on a 5-year basis. First recertification (5 years after original certification) requires passing a Written Examination

that covers the five (5) applicable ASTM Standards. If desired, first recertification participants can sit in on the 3-4 hour Education Session at no additional fee. Successful recertification will provide certification for a period of five (5) years from the date of completion and passing of all applicable recertification requirements and a new certificate and wallet card will be issued by ICRI.

Completing the Demonstration and Workshop will waive the previous testing experience requirement necessary for taking the Certification Course. All five (5) ASTM tests included in the Certification Course will be demonstrated with opportunity for hands-on testing and training by our instructors/judges.

By passing both the written and performance exams, an ICRI Concrete Slab Moisture Testing Technician – Grade 1 certification will be issued by ICRI, and the individual will receive a certificate and a wallet card. ICRI Concrete Slab Moisture Testing Technician Certification-Grade 1 certification is valid for a period of five (5) years from the date of completion and passing of all applicable certification requirements.
